

GENERAL LIABILITY SAFETY RELEASE FORM

- 1. I understand that other dogs will be present during grooming, boarding, and/or daycare services, and that my dog may have direct contact with these dogs during their stay.
- 2. I certify that my pet is current on all required vaccinations. For dogs, this includes: Canine Distemper, Parvovirus, Hepatitis, Parainfluenza (DHPP), Bordetella (Kennel Cough), and Rabies. For cats, this includes: Feline Viral Rhinotracheitis, Calicivirus, Panleukopenia (FVRCP), and Rabies. I acknowledge that proof of current vaccinations is required for all services. I understand the vaccination requirements for participation in services at The Barking Lot, LLC are as follows:
 - Dogs: DHPP within the last 3 years for adults (1 year for puppies), Bordetella within the last 6 months, and Rabies as required by local law (also mandatory for grooming services).
 - · Cats: FVRCP within the last year and Rabies in accordance with local laws.
- 3. I understand that my pet may be exposed to the infectious diseases listed above. However, as The Barking Lot, LLC has advised me that my dog should be fully vaccinated prior to participating in any services, I assume full responsibility for any illness or exposure that may occur. In the event of a medical emergency, The Barking Lot, LLC will make every effort to contact me. If I cannot be reached, I authorize the staff to seek immediate veterinary care at their discretion. I am responsible for all related costs.
- 4. I understand that due to the sometimes unpredictable nature of animals, interactions between pets may occur that could result in injury to my pet, other animals, or people. I assume full responsibility for any such incidents. I hereby waive and release The Barking Lot, LLC and its employees from any and all actions, claims, damages, or liabilities arising from:
 - (a) any personal injury or property damage resulting from interactions between pets during participation in any services; and
 - (b) any injury, illness, or disease my pet may contract during or as a result of participation in grooming, boarding, or daycare services.
- 5. I understand that The Barking Lot, LLC has taken precautions by providing a secure outdoor enclosure for pets to use for bathroom purposes. While the area is enclosed with a six-foot perimeter chain-link fence, I acknowledge that animal behavior can be unpredictable. In the event that my pet escapes the enclosure, I waive and release The Barking Lot, LLC from any and all actions, claims, damages, or liabilities arising from injury, illness, disease, loss, or death of my pet.
- **6.** I understand that if I do not pick up my pet within seven days of the scheduled pick-up date, and no alternate arrangements are made, The Barking Lot, LLC may consider the pet abandoned and take appropriate action in accordance with state law.
- 7. I understand that The Barking Lot, LLC reserves the right to refuse service to any pet that poses a risk to staff, other animals, or itself, including pets that exhibit aggressive, destructive, or highly anxious behavior. I acknowledge that pet behavior can be unpredictable and that The Barking Lot, LLC will act in the best interest of all animals and staff in determining appropriate care. I waive and release The Barking Lot, LLC from any and all claims or liability resulting from such behavioral decisions.
- 8. I give permission for The Barking Lot, LLC to take photos or videos of my pet during their stay and use them for social media, website, or promotional purposes.
- 9. I have read and understand this release form, and I agree to honor and abide by the terms and conditions outlined above, as well as all policies set forth by The Barking Lot, LLC.
